What are the requirements for students and staff to wear masks in school buildings?

Students and staff are to wear a mask at all times on the bus and at school, except while eating. Reusable, 3-ply cotton face masks and face shields will be provided for students. Families also may choose to provide a mask for their child(ren). CDC recommendations for masks for community use specify non-valved, multi-layer cloth masks to prevent transmission of SARS-CoV-2. This refers to the use of well-fitting cloth face masks or face masks to cover a person's mouth and nose to prevent spread of respiratory secretions when they are talking, sneezing, or coughing. Students may wear a gaiter if they already have a face mask underneath the gaiter; they cannot be worn alone.

It should be noted that some students are unable to wear masks for any of several acceptable reasons, which are addressed on an individual basis. All students are welcome in classrooms and other building spaces, although those who are unable to wear a mask may be moved in/out of specific areas when needed. Please contact your child's teacher or school administrator with any specific concerns.

Can I/my child switch to a virtual instruction model after committing to an in-person learning model at any time during the 2020-2021 school year?

Yes. Parents/guardians will have the option of moving their student from in-person to virtual at any time. Additional information is provided online about a switch from virtual to in-person and the absence of a requirement for students to return in-person for the 2020-2021 school year.

Can I/my child switch to an inperson learning model after committing to remaining fully virtual for the remainder of the 2020-2021 school year?

Parents/guardians who opt for their student to remain fully virtual may request to switch to the hybrid in-person model at any time during the 2020-2021 school year. However, approval of that request is dependent on available space, social distancing guidelines, and other factors.

Will students transition to different classrooms throughout the school day?


Elementary school students who are in-person will transition physically to different classrooms throughout the day as needed. These transitions may include mathematics class, related arts classes, and lunch. Students attending virtually will transition into different Google Meet virtual classrooms throughout the day. Schools will utilize social distancing strategies such as one way hallways, direction signs for two way hallways and staggering the dismissal of classes if needed to assist with the social distancing of students. Teachers may also utilize outside learning spaces, weather permitting, when applicable.

Middle and high school students who are in-person will transition physically to different classrooms throughout the day and those learning virtually will transition into different Google Meet virtual classrooms throughout the day. Schools will utilize social distancing strategies such as one way hallways, direction signs for two way hallways and staggering the dismissal of classes if needed to assist with the social distancing of students. Teachers may also utilize outside learning spaces, weather permitting, when applicable

How will students attending inperson eat lunch?

Students receiving in-person instruction will eat lunch in the cafeteria on their assigned lunch shift. Students will eat at desks in the cafeteria that are spaced six feet apart.
